Rebate Dollars Help Pay for Equipment or System Enhancements that Improve Energy Efficiency

All energy loss is waste, and waste is lost revenue to you. Xcel Energy's heating system rebates encourage a wide variety of equipment replacement to target energy loss and increase your efficiency, such as:

- New or replacement hot-water boilers that meet minimum efficiency requirements and are used for space heating and/or domestic water heating
- Furnace rebates
- Hot water heater rebates
- Replacing faulty steam traps
- New burners and control systems, such as outdoor air reset and stack dampers that increase the seasonal efficiency of your boiler
- Pipe insulation
- Boiler tuneups that maintain the peak efficiency of your system (Rebates available every other year)



HEATING EQUIPMENT CONSIDERED FOR REBATES THROUGH THE CUSTOM EFFICIENCY PROGRAM

- Steam boilers
- Boiler systems and auxiliary equipment that don't provide space heating or domestic water heating
- Boilers larger than 10 MMBTUH
- Blowdown heat recovery
- Stack economizers
- Self-contained radiator valves
- Energy recovery ventilators
- Linkage-less controllers

These must be preapproved prior to purchase and installation.

HOW MUCH DO YOU PAY FOR SPACE HEATING AND DOMESTIC WATER HEATING?

It depends on your business, but according to the U.S. Energy Information Administration, it breaks down as follows:

No matter how much your heating equipment contributes to your energy bill, increasing efficiency is a green choice – lowering your energy use and environmental impacts, and ultimately saving you money.

Rebate Guidelines

Customers must receive retail natural-gas service from Xcel Energy to qualify for Heating Efficiency rebates. Natural gas must be the primary fuel, but systems with dual-fuel capacity can qualify. Efficiency is based on thermal efficiency using a natural-gas fuel. 1 million BTU per hour = 1 MMBTUH.

Plan A – is for the installation of a new boiler where there was no previous boiler in place, or the current boiler is no longer operational.

Plan B – is for the replacement of a functioning boiler that is less than 25 years old. Supporting documentation must be provided. If the boiler to be replaced is functional, but more than 25 years old, it will qualify for Plan A.

Greater than 150,000 BTUH and minimum of 92% efficiency	\$350

Boiler tuneups	\$250 per MMBTUH

Boiler Efficiency Improvements	Rebate available
Modular burner controls \geq 5:1 turndown ratio	\$750 / MMBTUH; \$2000 max
Outdoor air reset controls	\$250 per MMBTUH
Stack dampers	\$250 per MMBTUH
Steam trap replacement/parts	25% up to \$250 per trap; maximum \$10,000 per facility
Other controls or improvements	Apply for Custom Efficiency rebate per approval prior to purchase and installation
