Eligibility requirements and process

To begin the process of an energy assessment, pre-approval is required and the customer and assessment provider should follow the steps below.

Please submit the following to Xcel Energy at the preapproval application phase:

1. Assessment application with completed preapproval section
2. Copy of the assessment proposal from the study provider. The proposal should provide descriptions of the building/space and the energy impact measures discovered in the walk through that will be investigated further. The proposal should address the following items:
 - a. What are the existing systems included in this assessment?
 - b. What are the customer's concerns, issues, or problems that were discovered during the walk through?
 - c. What are the preliminary recommendations to be proposed in this assessment based on the initial walkthrough?

4. Xcel Energy reserves the right to perform pre- and post-installation energy testing and data collection.
5. Xcel Energy reserves the right to accept or reject any application, assessment, or portion thereof.
6. Xcel Energy's conservation rebate programs are subject to 60 days notice of cancellation.
7. Xcel Energy reserves the right to conduct inspections of installation and/or make a reasonable number of follow-up visits to customers' facility to verify savings estimates and/or measure implementation.
8. Xcel Energy reserves the right to limit future assessment rebates if customer fails to turn in completed paperwork after the opportunity has been completed and/or the customer doesn't implement measures from past assessments.

Assessment approval

Assessment provider submits completed assessment report electronically to Xcel Energy with:

1. Completed energy roadmap report
2. Energy calculations
3. Copy of assessment calculator tool

Upon Xcel Energy approval of the final assessment, the assessment provider should send a final copy of the assessment report (and invoice if applicable) to the customer and the Xcel Energy account manager. After the assessment is approved, the assessment provider should invite the Xcel Energy account manager to the final report presentation meeting.

Terms, conditions and responsibilities

1. The assessment provider performing the assessment must do so with impartiality towards equipment suppliers, distributors, and all equipment or product brand names.
2. Xcel Energy's decision relating to customer eligibility for the assessment or other issues will be final and binding for all parties.
