

2015 South Restoration Schedule April 13, 2015

As we use different restoration contractors in Colorado, the following is our schedule for our largest contractor. This schedule represents restoration for Electric and/or Gas Distribution projects including AMRP (Accelerated Main Repair Program), CAB (Cellulose Acetate Butyrate gas service replacement), FasTracks (Denver area Regional Transportation District), RECON (Gas and/or Electric Reconstruction), and UCR (Underground Cable Replacement) projects.

Even though the weather is improving in Colorado, the condition of the sod that our contractors receive from their suppliers is not in the best condition. Since it is still early in the season, many sprinkler systems have not been charged up for the new season and new sod will require a daily watering schedule for at least two weeks. We anticipate sprinklers will be turned on and the condition of the sod will allow us to start laying sod around the end of April to early May.

We do our best to maintain the schedule and appreciate your patience. Our objective is to complete restoration subject to weather conditions, availability of restoration materials, and ground conditions. Soft surface restoration refers to dirt, seed, sod, erosion control blanket, landscape rock, or similar items. Hard surface restoration refers to blacktop, concrete, or similar items.
